## 2024 Swine Start Up Program

The swine committee is looking for new and current 4-H members who would like to participate in the Swine Start Up Program for 2024. Contact the office today at 937.382.0901 if you would like to sign up for the program. Swine Start Up is for first-time swine exhibitors. Exhibitors must sign up for a market swine project and pay a \$25 non-refundable deposit by March 15 at the OSU Extension Office. The total cost for the program is \$125 and is due by project pick-up in April. Members will receive a market hog from a local breeder plus other start-up supplies, special educational sessions, and QA training. Make sure when you are completing your 4-H/FFA enrollment you sign up for Market Swine Project #139. More information and requirements will be shared after sign-up.

## 2024 Goat Start Up Program

The Goat & Sheep committee will also be providing a Goat Start Up Program next year. They are looking for new and current 4-H members who would like to participate in the Goat Start-Up Program for 2024.

Contact the office today at 937.382.0901 if you would like to sign up for the program. Goat Start Up is for first-time goat exhibitors. Exhibitors must sign up for a market goat project and pay a \$25 non-refundable deposit by March 15 at the OSU Extension office. The total cost for the program is \$150 and is due by project pick-up in April. Members will receive a market goat from a local breeder plus other start-up supplies, special educational sessions, and QA training. Make sure when you complete your 4-H/FFA enrollment you sign up for Market Goat Project #135M. More information and requirements will be shared after sign-up.

## **Ohio State Fair Beef Information**

The Ohio State Fair requires all market beef entered in the 2024 Ohio State Fair to have individual DNA samples taken from each animal that may potentially be entered. These DNA samples must be in the possession of the Ohio State Fair by January 15. **NEW for 2024: Ohio State Fair will NOT be providing EID tags for market beef entries.** Exhibitors must get their own 840 tags for their entries. The EID 840 tag number MUST be listed on the envelope with the DNA sample.

DNA sample collection kits may be picked up at the Clinton County Extension Office in early December and will be available at the December 6, 2023, Beef Tag In. Prior to submission, the nomination envelope for each sample kit remitted must be signed by either the 4-H professional or FFA advisor, depending on which organization the youth is taking the market animal(s).

Also, note that youth showing at any of the BEST sanctioned shows must have EID tags in their calves prior to the first show in which they exhibit. BEST shows before the January 15 deadline to submit samples to OSF include *Mardi Gras Masquerade* (November 17-19, Circleville), *AGR Holiday Classic* (December 8-10, Columbus), *Saddle & Sirloin Spectacular* (December 29-31, Circleville), and *Scarlet & Gray Midwest Showdown* (January 5-7, Columbus).

#### Teens!

**NEW Junior Poultry Committee-**Application due January 15. Open to youth interested in serving the poultry department, must have at least two years of poultry project experience, and must be 14 by January 1, 2024.

**Carteens** is a teen leadership opportunity open all year round with no application requirement. For youth ages 14-19.
