Cat Project Requirements

- 1. Members must be currently enrolled in Cat 1-Purrfect Pals, Cat 2, Climbing Up! Or Cat 3, Leaping Forward
- 2. Members must have possession of cat by May 1 and complete Jr. Fair entries by May 1.
- 3. Each project book is meant to be completed within three years. Complete different activities each year according to your interest and experience.
- 4. The Junior Fair program reserves the right to combine classes based on participation/exhibitor entries, including skillathon.
- 5. <u>Cats must be a minimum of 15 weeks old by July 6, 2024.</u> Kittens less than 15 weeks old are not permitted on the Fairgrounds.
- 6. Cats must be immunized against Feline Panleukopenia (FPL), Feline Viral Rhinotracheitis (FVR), and Feline Calcivirus (FCV), OR vaccinated according to the veterinarian's vaccination protocol. All cats MUST be immunized against Rabies. (Note: Immunization against Feline Leukemia (FeLV) is strongly recommended for the protection of your cat, however, not required.) All vaccinations must be current.
- 7. Proof of vaccinations must be turned into OSUE Clinton County by June 1, 2024.

Purr-fect Pals, Level 1

Learn about being a good cat owner by taking this beginning-level cat project. You also learn about cat breeds, behavior, good health, grooming, and feeding. Designed for youth in grades 3 to 5 but can be taken by any youth in the first three years of this project. Complete at least 7 activities each year in the project. Exhibitor must have a visual display that could consist of a scrapbook or poster, etc.

Climbing Up! Level 2

Build on what you learned in Cat 1 by taking this intermediate level cat project. Learn more about cat identification and characteristics, training and showing cats, health and nutritional needs of cats, and responsible cat ownership. Designed for youth in grades 6 to 8 but may be taken by youth in any grade after they complete Cat 1. Cat 2 can be taken for three years. Complete at least 7 activities each year in the project. Exhibitor must have a visual display that could consist of a scrapbook or poster, etc.

Leaping Forward, Level 3

Delve deeper into some of the cat topics you've already explored in Cat 1 and Cat 2 (breeds, nutrition, health, and behavior) and meet some new topics (genetics and aging cats). Investigate various cat-related careers and practice your organization and presentation skills. Designed for youth in grades 9 to 12 but may be taken by any youth after completing Cat 1 and Cat 2. Complete at least 7 activities each year in the project. Exhibitor must have a visual display that could consist of a scrapbook or poster, etc.

Cage Decoration Contest for Cats and Small Animals

Cages will be provided for exhibitors to decorate. Members may decorate a cage on Friday, July 5, 4-7:00 p.m. in the Jr. Fair Building or the day of the show from 8-10:00 a.m. in the Peterson Building.

The contest is open to junior fair cat and small animals exhibitors only. Members must decorate their own cage. The dimensions of the cage are: 18"L x 12"W x 14"H. Members may decorate on Friday, July 5, 4-7:00 p.m. in the Jr. Fair Building or the day of the show from 8-10:00 a.m. in the Peterson Building. Cages must be completely decorated and

ready for judging by 10:00 a.m. the day of show. Cages are provided so exhibitors should use a carrier or their own cage for transportation. . Judging will be based on safety and creativity. . If a cat is placed in the decorated cage, litter and food are optional. Water is required in the decorated cage. Decorations should be safe for the animal. Cats are not required to be placed in the cage during judging. Exhibitors have the option to display cages during fair week in the Junior Fair Building.

Cat Show

- Only one cat per exhibitor.
 Any exhibitor showing a cat that creates a threat to people or other cats will be asked to take the cat home.
- 3. Cats must humanely wear a harness or an attached leash during activities.
- 4. Exhibitors are responsible for their own cats.
- 5. Nursing queens will not be shown.
- 6. Females in season will not be shown.
- 7. Cat show is open to junior fair cat exhibitors only.

 - Study project book and learn characteristics of breeds, feeding and management practices, grooming, a. etc. of the animal you are studying.
- 2. Exhibit Requirement
 - a. Exhibit one animal from project on judging day only.
 - b. Participate in personal interview.
- 3. Small Animal exhibitors may bring in a poster to exhibit at the fair. Please bring posters to Junior Fair Building on Friday, July 5, 4 p.m.-7:00 p.m.
- 4. Youth exhibiting small animal projects such as chinchillas, hedgehogs, ferrets, caged birds, pot-bellied pigs, hermit crabs, etc. should sign up for the Self-Determined Project, No. 365.

Pet Rabbit Project Requirements

- 1. Pet Rabbit Class-This class is designed for 4-H members that are taking the Pet Rabbit Project & Record Book. Rabbits will not be shown in breed classes.
- 2. Pet rabbits do not stay in the barn during the week. They are brought in for the show only.
- 3. Pet Rabbits may participate in Rabbit Skillathon. (Optional)
- 4. Pet Rabbit exhibitors may bring in a poster to exhibit at the fair. Please bring posters to the Junior Fair Building on Friday, July 5, 4 p.m.-7:00 p.m.
